17. Managing Director will have full authority to award the contract for the Bidding items on part or full and the number of units to which the annual maintenance is to be affected.
18. TERMS AND CONDITIONS

1) Scope of Work: Bidder

Following are the key works those the bidder has to carried out

- 1) Supply, Installation, Testing, Commissioning & Operation of in-house Glass Bottling Machine at The Leela Hotel, Gandhinagar
- 2) Necessary MEPPF work for the said installation and commissioning from the given source as per the instruction of GARUD. The bidders are advised to visit the site before quote to understand the actual site condition.
- 3) The successful bidder provides operational manpower of the machine (8 hours per day) to produce minimum of 3000 bottles in a day. Bottles neck ring removal, washing, drying and filling is part of scope except transporting to user area. Manpower should be supplied for 365 days a year.
- 4) The printing content on the bottle will be finalized by the GARUD. The necessary content will be provided by GARUD.
- 5) The said machine is to be installed at the First Service Floor Area at The Leela Hotel, Gandhinagar at the designated place (approx.. 400-500 Sqft).
- 6) The successful bidder provides necessary chemicals and consumables for the machine operation except bottles, caps and seal as per the requirement without any extra cost during the period of warranty/ guarantee after successful installation and commissioning.
- 7) The bidder completes the supply, installation, testing and commissioning within 12 weeks from the date of Work Order.
- 8) The successful bidder provides the Manual and SOP for the operation of the machine as per the standard practice.
- 9) During the warranty / CAMC Period, the empty Glass Bottles and consumables will be provided by GARUD.
- 10) The bidder may quote separately price for second year onwards for each year. GARUD reserve right to invite open tender for procurement of same glass bottles and machine should be capable to handle such bottles.
- 11) Bidder / Operator should ensure regular maintenance and cleaning of machines as per OEM standards. Maintain machines in operational condition at all the times. All the necessary spares and chemicals are part of Bidder / operator scope.
- 12) Daily pH and TDS test to be carried out in house by bidder / operator and keep the records for it.
- 13) The bidder minimum of 1 external lab test (Total 12 test during the O&M period) shall be done by bidder in external Government laboratory on monthly basis and all in house test (i.e. TDS and PH) to be carried on daily basis as per production and ISO test to be carried as per FSSAI guidelines, any added test will be paid by GARUD/Leela on actual against bill submission.
- 14) In the unlikely event that the water parameters fail to meet required standards with the pathology lab, step should be taken to empty filled bottles and measures to be taken for corrective measures. It is part of bidder / operator scope.
- 15) Bidder / Operator will take liability of proper functioning of plant and equipment as per terms of Operation and Maintenance contract.
- 16) Response and resolution period is : 24 hrs
- 17) An adequate supply of critical spares should be maintained by O&M operator.
- 18) All the bottles will be kept in usable and transporting condition at designated inside bottling plant.

2) Scope of Work: GARUD / LEELA

- 1) Providing a closed room with dust free environment. Plant room size: 400 to 500 Sqft with washable tiled flooring and tiled wall covering up to 6 ft, false ceiling. Entrance door with door closer with 1.5 m W x 2.5 L
- 2) Air conditioning unit min 2 ton to maintain inside temperature. Well- light arrangements.
- 3) Wall rack to accommodate water samples. Closed metal cabinet 4ft x 3ft x 2ft to store chemicals.
- 4) Utility air compressor to provide inside the room to provide min 7 to 10 bar
- 5) All electricals' connections with MCB to provide at the installation area with proper cable dressing and termination as per requirements of bidder electricity requirements.
- 6) Necessary plumbing requirements with hot and cold water, drain facility provided as per bidder requirements.
- 7) Collecting and transporting fresh and used bottles with washable crates from and to the bottling area is part of Leela scope. There will be additional manpower for the same.

3) CAMC period:

The CAMC period has been agreed as 36 months from the date of issuance of Work Order without any extra cost. This can be extended further upon mutual consent of both the parties.

4) Compliance to the Labor Laws

You as the Contractor shall have to comply with all the prevailing labour laws including the Minimum Wages Act, Employees' Provident Fund, Workmen Compensation, Labor Welfare and all other related laws and the rules made there under without fail and shall indemnify GARUD against any claims that may crop up arising out of non-compliance of these laws and rules. You shall also obtain labour license from the Labor Commissioner and also necessary insurance as per the rules.

5) Compliance to Safety Norms & Regulations:

The Agency shall comply all the requirements and safety norms & regulations applicable to and at the site during execution of all work. Please ensure that you have obtained necessary Agency License or with your sub-Agency which shall in turn be produced before GARUD without fail. Structural stability of all temporary structures shall be ensured from competent Structural Engineer. It is the basic requirement of the contract. Safety is the essence of this contract.

6) Coordination:

You as the Contractor shall work under the close coordination and under day to day monitoring of the GARUD and Concerned Authority, at the site and maintain the record book, measurement book which delineates the preciseness of the times to be verified at the site from time to time our Engineer/s and or representative/s will also make visit and access to anywhere at the place of work.

7) Compliance of the instructions given by GARUD/Concerned Authority:

All the instructions given by GARUD/Concerned Authority shall be incorporated shall be strictly observed while executing the work. The quality and time are the essence of the work, which shall be noted.

8) Work Specifications:

You as the Contractor shall have to all the work instructed by GARUD/ Concerned Authority.

9) Contract Agreement:

The Letter of Award by itself shall constitute a legally binding and valid concluded Contract Agreement between you as the Contractor and GARUD as the Employer. The Agreement shall remain valid and effective from the date of issuance of this Letter of Award up to the date of issuance of satisfactory Work Completion Certificate to be issued by GARUD as the Employer. A formal Contract Agreement stating that the parties have agreed to the Terms and Conditions set out in the Letter of Award which has been made a part of Contract shall be signed and entered into immediately on payment of the Security Deposit by the Contractor.

10) Variations:

Variations in the work in the form of extra items shall not be executed by the Contractor unless a specific, valid and binding "Variation Order" is issued by the Competent Authority of GARUD. Any extra item / variations executed by the Contractor without such valid "Variation Order" shall be outright rejected and the Contractor shall not be entitled to claim any payment towards such variations.

11) Payment:

Payment of the Contract Price, towards satisfactory completion of the work by you as the Contractor and its acceptance by GARUD shall be made in the form of "Running Account Bill" to be raised by you and certified by the Competent Authority of GARUD. Payment on such certification shall be released within a period of 30 days from the date of certification. No interest claim against any delay of payment shall be payable by GARUD.

12) Termination:

GARUD shall have exclusive and undisputed authority to terminate the Contract on the grounds of poor performance of Contract or non-performance of the Contract or compromise in quality of works by issuing a Notice of Termination. On such termination, the rights arising out of this Letter of Award shall cease.

13) Liquidated Damages:

The Contract period is 36 months. If work is not completed as per specification and as per time schedule, liquidated damages will be levied for the work delayed / non-performance of the work will be imposed at the 1% of rate of quoted price of such item for a work. Maximum up to 10% of the contract value. **For Glass bottles :-** Fresh tender will be floated to procure glass bottles for every subsequent procurement of glass bottles after expiry of 12 month from the date of first supply of glass bottle, hence this clause will be not be applicable for subsequent supply of glass bottles.

14) Loss and Damages:

Any loss or damages or deterioration of the material in transits shall be at the cost of the bidders. It shall be at the discretion of the GARUD to reject, damaged or spoiled material, if so noticed. During the work, if any property of client damaged than book value/ repair cost + 20 % of same should be recovered from bidder.

The Bidder will not be held responsible for instances which are beyond bidders control. If bottles are in damaged condition after delivery at Leela site and bidder will not be held responsible, but the bidder has to inform about the damages in received bottles within 24 hours of receipt of bottles. Bidder has to maintain suitable stock register for this purpose.

15) Jurisdiction of Courts:

The Courts at Gandhinagar / Ahmedabad shall have exclusive jurisdiction in all matters relating to this Letter of Award cum Contract Agreement.

16) Dispute Resolution:

Any dispute arising out of this Letter of Award cum Contract Agreement shall be first resolved through amicable settlement between the Contractor and the Employer (GARUD). In case if the process of amicable settlement fails, the dispute shall be referred to a Sole Arbitrator for adjudication as per the Indian Arbitration and Conciliation Act 1996 read along with its amendment in 2015 & 2019. Costs of Arbitration shall be equally shared by the Contractor and GARUD. The Arbitration Proceedings shall be carried out at Gandhinagar.

17) Force Majeure:

- a. Neither party shall be liable to the other for any loss or damage occasioned /caused by or arising out of act of God and in particular, Unprecedented floods”, volcanic eruption, earthquake or other convulsion of nature and other acts, such as but not restricted to invasion, the act of foreign countries, hostilities or war like operations before or after declaration of war rebellion military or usurped power (but excluding strikes and lockouts) which prevent performance of the contract and which could not have been foreseen or avoided by a prudent person.

Note: Unprecedented flood; means the flood crossing the highest observed flood level which is on the available record.

- b. If any loss or damage happens to the works, or any part thereof, or materials or plant for incorporation therein, during the period for which the contractor is responsible for the care thereof, from any cause whatsoever, other than the risk defined in the clause 17 (a) as above, the Contractor shall at his own cost, rectify such loss or damage so that the permanent works conform in every respect with the provisions of the contract to the satisfaction of the GARUD/Leela Authority.

17) You are required to sign & seal the second copy of this Letter of Award, in token of confirmation and acceptance of the Terms and Conditions set forth herein above within a period of 10 days from the date of issuance of this Letter of Award. If you fail to send the signed copy within the period of 10 days as stated herein above, this Letter of Award shall be deemed to be cancelled without any specific notice to be issued by GARUD.
