Section: 1 Introduction

7.2 Two-Cover Bid System

FINANCIAL BID SUBMISSION:

Key Points:

- 1. The **Total Amount** shall be quoted in **Indian Rupees (INR)**, **exclusive of GST**.
- 2. The quoted amount must include all applicable **duties**, **transportation charges**, **loading/unloading fees**, and any other associated costs.
- 3. **Applicable GST** will be paid **separately** as per prevailing rates.

DISQUALIFICATION CLAUSE:

 Bidders submitting the financial bid in physical form shall be disqualified from the tendering process.

Section 8: GENERAL CONDITIONS

1. Submission of Technical Bid:

 The technical bid must be submitted in hard copy at the GARUD Office at 3rd Floor, E1 Wing, Block no. 3, Karamayogi Bhavan, Sector – 10A, Gandhinagar, Gujarat.

2. Compliance with Orders:

• Supplies and services must strictly adhere to the order specifications provided. Any unauthorized additional supplies or services made without prior written approval from the authorized officer will not be compensated.

3. Penalties for Delays:

 If the bidder fails to deliver supplies or services within the agreed time frame, they will be liable to compensate the authority for any damages or losses incurred due to the delay. This compensation may be recovered from pending payments, EMD, or Security Deposit.

4. Alternate Arrangements:

 The authority reserves the right to procure supplies or services from other bidders if necessary. Should the original bidder refuse to accept the award or comply with the terms of the contract, their EMD or Security Deposit may be forfeited.

5. Compliance with Formalities:

 The successful bidder must complete all necessary formalities, including obtaining required permissions or licenses, before delivering supplies or services to the premises.

6. Modification Rights:

• The authority reserves the right to modify any terms and conditions of this tender on genuine grounds as deemed necessary.

7. Payment Conditions:

 Payments will be processed based on compliance with the terms outlined in the tender.

8. Contract Termination:

• The authority retains the power to terminate the contract at any time if the bidder is found to be unsuccessful. In such cases, the contract may be awarded to another agency without the original bidder's contestation.

9. <u>Dispute Resolution:</u>

 Any disputes arising during the course of the contract will be referred to the Commercial Court of Ahmedabad, Gujarat, which will have jurisdiction over such matters.

10. Ongoing Obligations:

• The authority reserves the right to request continued supply or service under the same contractual rates and conditions, and the bidder is obligated to comply.

11. Supply/Service Guarantee:

• The successful bidder must provide an undertaking to deliver supplies/services as per GARUD's/Leela's requirements and the scope outlined at the agreed rates.

12. Liability for Damages:

• In the event of losses, damages, theft, or embezzlement during transit, GARUD/Leela will not be held responsible. Suppliers are advised to secure Transit Insurance.

13. Force Majeure:

• In the event of unforeseen circumstances beyond control (force majeure), the terms of this contract may be adjusted as necessary.

14. Contract Extension:

The contract may be extended for a year upon mutual agreement between the bidder and the authority. The terms and conditions, including the rates, will remain the same as specified in the original contract unless otherwise renegotiated and agreed upon in writing by both parties.

Section 9: TERMS AND CONDITIONS

1. PRICE/RATE

- Prices must include all charges, excluding GST, which should be quoted separately.
- Prices are fixed and not subject to variation for the order. Any amendment expressly referring to the order will invalidate the said work order.
- o Prices should be FOR (Free on Road) at The Leela Gandhinagar/MMCEC.

2. Insurance

- The Service Provider must, at their own expense, ensure comprehensive insurance coverage for all personnel engaged in the services under this Agreement.
- The insurance policy must cover illness, injury, accidents, disability, and death during the execution of the services.

3. Quality

- The Service Provider shall deliver services with the highest level of care, skill, and diligence, adhering to industry-best standards.
- All work must meet or exceed the agreed-upon specifications, quality, and performance criteria.
- Only qualified personnel and high-quality materials are to be used for maintenance, repair, and installation activities.

4. Confidentiality

 The vendor must not use any blueprints, drawings, designs, or manufacturing data provided for The Leela Gandhinagar for any purpose other than the execution of this contract.

5. Delivery/Service

- a) Services must be completed within 48-72 hours. Failure to repair within this timeframe, resulting in repairs by an external provider, will render the bidder liable for the full cost of such repairs.
- b) The PO/SPO number must appear on all service invoices.

6. Quantity

- Services will be billed monthly. Each technician must work a minimum of 26 days per month, resulting in a total of 52 workdays per month for two technicians.
- o Any shortfall in the required number of workdays will result in proportional deductions from the monthly payment.

7. Payment

- Payment will be made within 45 days of receiving the invoice, or as specified in the agreement.
- o Invoices must be submitted within the first week of the following month

for services rendered.

8. Rejected Goods

• The Leela/GARUD reserves the right to reject any defective, non-conforming, or substandard goods, spare parts, or materials used during service.

11. Disputes

 Any disputes arising from this order will be under the jurisdiction of the Commercial Court in Ahmedabad.

12. Warranty/Guarantee

- The Service Provider warrants that all services provided will be free from defects and conform to the agreed-upon specifications and standards.
- This warranty covers all maintenance, repairs, replacements, and other services under the contract.

13.GST Registration

 Both parties must display their GST Registration Numbers on all invoices and orders.

14. Inducements or Bribery

 Any act of offering or giving inducements, rewards, or gifts to Authority personnel will result in immediate contract termination. The Authority may recover any resulting losses or damages.

15. Non-Performance Clause

- The agency must provide services as outlined in **Section 10** (**Scope of Work for Kitchen Equipment Service & Maintenance**).
- A written warning will be issued for non-performance. Upon receiving three warnings, the contract will be terminated, and the bank guarantee/security deposit will be forfeited.

Section 11: COMPLIANCE AND EXECUTION TERMS

Compliance with Labor Laws

- The Contractor must comply with all prevailing labour laws, including the Minimum Wages Act, Employees' Provident Fund, Workmen Compensation, Labor Welfare, and other applicable laws and regulations.
- The Contractor shall indemnify GARUD against any claims arising due to non-compliance with these laws and rules.
- The Contractor must obtain a labour license from the Labor Commissioner and procure necessary insurance as required by law.

Compliance with Safety Norms and Regulations

- The Contractor shall adhere to all safety norms and regulations applicable at the site during work execution.
- The Contractor must ensure the stability of all temporary structures, certified by a competent Structural Engineer.
- Obtaining the necessary Agency License or ensuring compliance through sub-Agency is mandatory.
- Safety is a critical requirement of this contract.

Coordination

- The Contractor shall work under the close coordination and day-to-day monitoring of The Leela and the Concerned Authority at the site.
- A Daily Progress Report must be maintained and verified on-site.
- Engineers or representatives from GARUD or The Leela will conduct regular inspections and have unrestricted access to the work site.

Compliance with Instructions

- The Contractor shall strictly adhere to all instructions issued by The Leela or the Concerned Authority during work execution.
- Quality and time are critical aspects of the work and must be prioritized.

Work Specifications

• The Contractor is obligated to execute all work as per the instructions provided by The Leela Gandhinagar.

Contract Agreement

- The Letter of Award constitutes a legally binding contract between the Contractor and The Leela Gandhinagar/GARUD as the Employer.
- The Agreement shall remain valid from the date of issuance of the Letter of Award until a Satisfactory Work Completion Certificate is issued by The Leela/GARUD.
- A formal Contract Agreement, encompassing the Terms and Conditions of the Letter of Award, shall be signed upon payment of the Security Deposit by the Contractor.

Variations

- No variations, including extra items, shall be executed by the Contractor without a valid Variation Order issued by the Competent Authority of The Leela/GARUD.
- Any extra items or unauthorized variations executed without such an order shall be rejected outright, and the Contractor shall not be entitled to claim any payment for the same.
