### **Section: 2 INTRODUCTIONS**

- 3. Tenders will be considered firm for acceptance for a period of twelve months from the Issuance of LoA. Tenderers are not free to withdraw or modify the tenders during this firm period. The tenderer must sign all pages of tender form.
- 4. The accepted tender form of the tender notification, terms & conditions of this contract, specifications and general conditions shall form part of the agreement.
- 5. The tender should be free from errors and corrections, if any should be made neatly and attested by the tenderer. The number of corrections in each page of tender schedule should be noted in words at the bottom of each page.
- 6. The quoted rates should be Exclusive of GST but Inclusive of insurance/packing/forwarding/freight charges/monogram printing charges and all other incidental charges if any. The quoted rates should be given both in figures and words. Alternative proposals/rates are liable to be rejected.
- 7. The material shall be of the best quality and of the exact kind, quality and description demanded and if any stage these are found unsuitable/sub-standard shall be liable to be rejected by the Authority, the decision shall be final and binding on the supplier. - **2.** The supplies shall be made as per the order.
- **3.** Any additional supplies made by the suppliers without written authority of the authorized officer, will not be paid for.
- **4.** If the bidder fails to provide supplies in the agreed time, he has to pay to authority the cost of damage and loss occurred due to his delay. If he fails to pay this sum in time, such sum arrived at shall be recovered from his pending payments from any other dues.
- **5.** Authority has the right to order the supplies/services to any other bidders in connection with this contract at any time, if found necessary. In case the bidder refuses to accept the award or refuses to comply with any of the terms and conditions for the award of contract, the Pending Payments/from any other dues shall be forfeited.
- **6.** The successful bidder shall complete all necessary formality & obtain permission/licence etc. as per rules before delivering the supplies/services to our premises.
- **7.** The Authority reserves the right to modify one or more or any of the terms and conditions of this tender on genuine grounds.
- **8.** Payments will be made based on the acceptance of the conditions in tender.
- **9.** Authority has the power to terminate the contract at any time, if found unsuccessful, and to award the contract to another agency, which cannot be questioned anywhere. Authority reserves the right to negotiate for reduction in the rates or to reject any or all tenders without assigning any reasons.
- **10.** In case of dispute or differences between the two parties arises during the course of contract, the same shall be referred to Civil Courts of Gandhinagar (Gujarat) and the jurisdiction of such matter will be at Gandhinagar (Gujarat) Courts only.
- **11.** The Authority reserves the right to call upon the supplies/services to continue the supplies/services at the contractual rates & bidder is bound to provide supplies/services at the same rate and Terms & Conditions.

- **12.** The successful bidder must give an undertaking that the bidder will make supplies/services will be provided as per GARUD's/Leela requirement and as per the specification of the rates offered.
- **13.** If the bidder fails to provide supplies/services of any of the items as per rates, the security deposited/any other due amount will be forfeited, in addition to other legal remedies available including termination of the contract & purchase of supplies/services at bidder's risk & cost.
- **14.** In case any losses/damages/theft/embezzlement in transit of goods, GARUD/Leela shall not be responsible. Thus, suppliers advised to take Transit Insurance.
- **15.** The successful tenderer will deliver the supplies to the Leela Hotel at Gandhinagar on demand of requirements.

### 16. Force Majeure

a. Neither party shall be liable to the other for any loss or damage occasioned/caused by or arising out of act of God and in particular "Unprecedented floods", volcanic eruption, earthquake or other convulsion of nature and other acts, such as but not restricted to invasion, the act of foreign countries, hostilities or war like operations before or after declaration of war rebellion military or usurped power (but excluding strikes and lockouts) which prevent performance of the contract and which could not have been foreseen of avoided by a prudent person.

Note: "Unprecedented flood" means the flood crossing the highest observed flood level which is on the available record.

b. If any loss of damage happens to the works, or any part thereof, or materials or plant for incorporation therein, during the period for which the contractor is responsible for the care thereof, from any cause whatsoever, other than the risk defined in the clause 30 (a) as above, the contractor shall at his own cost, rectify such loss of damage so that the permanent works confirm in every respect with the provision of the contract to the satisfaction of Owner.

### 17. Damages

If the Supplier/Service provider or his workmen, or servant if break, deface, injure or destroy or damage any part of the work in question in / on which they may be working or any building, road, fence, enclosure or grassland or cultivated ground continuous to the premises on which the work or any part thereof is being executed or if any damage shall occur to the work from any cause; Employer's Representative, or such other officer as he may appoint and the estimates of the Employer's Representative, subject to the decision of the Employer, on appeal, shall be final and

the Supplier/Service provider shall be bound to pay the amount of the assessed compensation on demand, failing which the same will be recovered from the Supplier/Service provider as damages in the manner as decided by the Employer's Representative and deducted from any sums that may be due or become due from the Employer to the Supplier/Service provider.

### 18. Extension of Contract (if required):

The contract of Supplying items/Services will be initially for 1 year from the contract and same can be extended for further one more year on the same terms and condition, same rate with mutual consent.

- **19. Penalty:** If the bidder fails to deliver supplies or services within the agreed time frame, The Leela Gandhinagar is entitled to get the Contracted Items from the market and the difference amount will be debited from the selected agency.
- **20.** If the such instances arise more than twice/thrice in a month, The Leela Gandhinagar is entitled to initiate the process of black listing the agency and forfeiting the any pending payment. The agency will have to abide by the decision of The Leela Gandhinagar.

### **Section 8: TERMS AND CONDITIONS**

### 1. Price/rate

Except as otherwise agreed in writing the stated prices are inclusive of raw material, manufacturing cost, freight, lead & lift, packaging etc. excluding GST which should be quoted separately. The price is not variable for order. Any amendment expressly referring to order shall invalidate the said Purchase order. The price should be FOR at The Leela Gandhinagar.

Fixed/contracted prices should not be changed during the contract period and not be exceeded form MRP & Scheme products should be come if mentioned on product packing. The price is not variable for all this orders. Any amendment expressly referring to this order shall invalidate the said Purchase order.

### 2. Insurance

The liability of insurance till delivery at the Leela Gandhinagar will be of the vendor unless agreed in writing.

### 3. Quality

All vendors must confirm to drawing and specifications. The company shall be free to reject goods unless the quality is approved by the competent officer, whose decision shall be final and binding on the vendor.

### 4. Confidentiality

The vendor shall not use any blueprint, drawings, designs, manufacturing data of specifications received for the manufacture or supply of the material for The Leela Gandhinagar in any manner whatsoever, or by anyone on the vendor's behalf for the purpose of sale.

### 5. Delivery

- a. The goods supplied should strictly confirm to the specifications / brands indicated on the order and/ or advance samples approved. Acceptance is subject to inspection and approval at the place of delivery/ or destination. Goods not found according to specifications etc. will be rejected at the vendors cost and expenses. The vendor must remove the rejected delivery and it should be made free at the premises.
- b. Although this order is placed for supplies to a definite destination, suppliers shall dispatch the goods to any other works or site under the company's management if so required by the GARUD.

- c. Delivery should be completed within the period specified on the order unless otherwise extended or relaxed by a competent authority. Should suppliers fail to execute order or any part thereof as stipulated, the company shall be free, without giving any notice to suppliers to purchase the undelivered goods from the market at the prevailing prices and the vendor shall be obliged to reimburse the GARUD in respect of any loss or damage arising from their failure to deliver the goods.
- d. The P.O. number must appear on all the packages Invoice & Challans.

### 6. Packing & Labelling

The goods shall be securely and suitably packed as per FSSAI ACT packaging and labelling ACT and safely delivered at Leela Gandhinagar or the place decided by the authority on this order in Gandhinagar. Any non-compliance will have to be compensated by the Supplier. Any breakage, damage or pilferage in transit arising from faulty packing shall be borne by Suppliers. Thus, rejected items will have to be replaced immediately.

### 7. Quantity

Goods will be paid for on the basis of net quantity received not exceeding the ordered quantity at work, irrespective of the quantity in the supplier's invoice.

### 8. Payment

Payment will be made within 45-60 days from receipt of bill or as may be otherwise specified in Purchase order for the material supplied by the vendor and received and accepted by Authority. The vendors should submit their bill to the Leela Gandhinagar within 7 days from the date of receipt of supplies/services by GARUD at Hotel.

### 9. Samples

- a. GARUD/Leela reserves right for sampling round before proceeding to execute this order, suppliers shall obtain the approval of samples of such goods as have to be obtained or manufactured to suit the requirements.
- b. If any samples are furnished to suppliers by the Authority, the same should be returned in good condition.

### 10. Rejected Goods

Rejected goods lying with the Authority will be at supplier's risk and should be removed by them at their own cost immediately on receipt of advice from the Authority to this effect. The Authority shall be entitled to recover from the suppliers this full amount of freight and other charges, if any incurred in respect of rejected goods.

### 11. Disputes

Any disputes arising out of this order will fall under the jurisdiction of competent court at Gandhinagar District court only.

### 12. Warranty/Guarantee

The supplier/vendor/manufacturer/aggregators must submit warranty/ Guarantee certificate issued by the original manufacturer to GARUD in original. Warranty/Guarantee in writing, either separately or on the Bill/Challans should accompany each supply made by the Seller as per prevailing Regulations of the Food & Adulteration Act (if applicable) or any other rules or regulations.

### 13.GST Registration number

GST Registration number must be shown on each invoice.

**14.** The Vendor shall not offer or give or agree to give to any person in the Authority any gift or consideration of any kind as an inducement or reward for doing or for bearing to do or for having done or forborne to do any act in relation to the obtaining or execution of this or any other order or for showing or for bearing to show favor or disfavor to any person in relation to this or any one employed by him or acting on his behalf whether with or without his knowledge shall entitle the Authority to terminate the order forthwith and to recover from the Vendor the amount of loss or damage suffered by the Authority.
